## **CORRESPONDENCE**

Review and discussion of submitted proposal received for a model railroad room/hobby craft room in the basement storage room of the main Activities Building. Following discussion and previous research by the Board Members, the following items are noted:

Basement is utilized and is required for storage of association items including historical records, pool furniture, decorations, etc.

Firebox controls for entire complex are located in the basement/water heaters/ furnace/electrical. Not ADA compliant – liability

From the diagram submitted, basically a train room - little space for hobby crafts

Unanimous decision of Board: Suggest seeking a different location as an option, such as: loft area in main building or quilt/ping pong table room in laundry/exercise building and resubmit to the Board.

# AC COMMITTEE

As a benefit to the owners in the Park and increase turnaround time of submitted AC Request Forms, it is the Board's unanimous decision the AC Committee will meet weekly during the months of May thru September; and, will meet on the 1<sup>st</sup> and 3<sup>rd</sup> Wednesday of each month during the months of October thru April.

## Trees at Park Entry/ Root Encroachment

Following much discussion and research by the Board, Motion was made by Max Archer to approve the Avid Tree Bid in the amount of \$3,878.71 for installation of root guard systems and materials and equipment to contain the encroachment of the tree roots and attempt to save the front entry trees lining the main drive into the Park; 2<sup>nd</sup> by Gary Hall; and, PASSED.
